2. Large Corporations

No BEE Certificate or scorecard needs to be submitted for the category below. A motivation needs to be submitted as to why the Deal or Project is deserving of an award.

3. BEE Deal/Project of the Year

**Entry Criteria:**

Entrants must:

1. Have a valid B-BBEE Certificate and Scorecard except for Category 3
2. Fall within the following categories i.e. large corporations (above R35 Million Annual turnover) or Medium Size business (between R5 and R35 million turnover), and BEE project/Deal
3. Demonstrate tangible improvements in the transformation of their organizations.
4. Be able to demonstrate high levels of inclusion of a broad-base of citizens in their empowerment.

4. Organisations with a KZN based head office must enter complete results.
5. Organisations with a head office outside of KZN must enter KZN results only. (Category classification will be based on KZN turnover).
6. Failure to submit results for any specific criteria will result in zero points being awarded for that criterion.
7. Judges may, at their discretion call for additional information to be furnished. Failure to provide this information will impact on points awarded in specific categories.
8. All finalist entries will be verified by AQRATE KZN. Companies are required to provide access to AQRATE KZN for the verification process.
9. One full year of measurable results must be entered - the most recent year.
10. There is no direct financial reward offered as part of the competition.
